Documents Need Checklist

The following documents needed to complete application:

- Gross Income-last 4 weeks (all adults in household), Self-Employment Form
- Verification Child Support & Families First/TANF, WIC, Updated SNAP Benefits
- Verification of SSDI, Social Security, VA/Retirement Benefits, FMLA
- Employment-Separation Notice, or Statement from Knowledgeable Individual of Crisis Need (Job loss must be due to no fault of your own)
- Unemployment Benefits Statement
- Support Statement-w/date, signature, cell number (If no income)
- Lease/Rental Agreement
- Rent Document completed by Landlord/Proof of \$500 balance owed
- Utility Bill/Medication-prescription/bottle-refill
- Photo ID
- Social Security Cards-all household members
- Bring All current bills, expenses and /or unexpected repairs/Documentation for Crisis- Receipts must equal amount needed for assistance
- NES customers must first apply with Needlink before CHORC appt.
